



## GLASS BREAKAGE LIMITED LIFETIME WARRANTY EASTERN REGION | 1600 SERIES & 1500 SERIES

**Applicability.** This Glass Breakage Limited Lifetime Warranty (“Glass Breakage Warranty” or “Warranty”) applies to all windows within the 1600 Series family manufactured after August 26, 2019 and installed in an owner-occupied residential dwelling. It also applies to windows in the 1500 Series family manufactured after August 26, 2019 and installed in an owner-occupied residential dwelling if glass breakage coverage is selected at the time of the sale of the windows and referenced on the Order documents. This Warranty is for the original product owner only and may not be transferred or assigned to subsequent owners.

This Glass Breakage Warranty is supplemental to the Limited Lifetime Product Warranty for replacement windows in MI’s Eastern Region (“Product Warranty”) and is subject to and incorporates all terms, conditions, disclaimers, and exclusions of the Product Warranty (available at [www.MIWindows.com](http://www.MIWindows.com) or by request at (717) 365-2500).

**Glass Breakage.** Upon proper notice of a claim by the Original Product Owner (“Owner”), MI will provide a sealed insulated glass unit (“IGU”) to replace broken or cracked glass in your window. Labor and shipping terms are the same as described in the Product Warranty.

**Glass Breakage Exclusions.** This Extended Warranty does not cover:

- Windows with laminated, tempered or impact-resistant glass;
- Windows with beveled or grooved glass;
- Windows with blinds between the glass;
- Glass in bay windows, bow windows, or sliding glass doors;
- Glass that breaks or cracks during handling, installation, construction of the structure, or removal of the window from the opening;
- Glass in two (2) or more windows damaged by a single occurrence of vandalism;
- Glass damaged by Acts of God, including flood, earthquake, high wind event, fire, civil unrest, war, or riot; or
- Glass in configurations or mullied combinations that exceed MI’s size limitations.

**Claim Process.** See Product Warranty for details on how to file a warranty claim for broken or cracked glass. In addition, Owner must show proof of original ownership. When seeking coverage for a 1500 Series window, Owner must also submit proof of purchase of this Glass Breakage Warranty.

**PLEASE REVIEW THE MI PRODUCT WARRANTY APPLICABLE TO YOUR WINDOWS PRIOR TO SUBMITTING A CLAIM. THE PRODUCT WARRANTY INCLUDES ADDITIONAL TERMS, CONDITIONS, DISCLAIMERS, AND EXCLUSIONS THAT ARE INCORPORATED INTO THIS WARRANTY AND ARE NOT RE-STATED HEREIN.**
